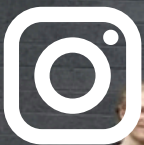

1. Who we are and what we stand for

Here you will read about the basis of the Young Greens and our philosophy as set out in the constitution. The full constitution is on the Young Greens website.

Philosophy, Principles, and Objectives

The principles assert the connection of all life and the role of the Green movement in establishing appropriate relationships in this web of interdependence. While respecting the human person, we recognise and celebrate our links with other species. We oppose the destructive processes which are destroying the planet. We favour a balanced and sustainable system of production and utilisation of resources, keeping account of real costs. The task before us is to transform the vision of continued viable life on Earth into reality.



Young Greens Principles

We have a responsibility to pass on a healthy planet to future generations

The poverty of two thirds of the world's population demands the fair redistribution of the world's resources

We want to build a green, feminist, democratic economy to oversee the fair redistribution of wealth, a just transition and intergenerational equity

There is no place for intimidation, violence or threats of violence in the democratic political process

We fight for intersectional feminism that is anti-racist, anti-fascist, and supports LGBTQ+ and disability rights

Unrestricted economic growth must be replaced by an ecologically and socially just economy

All political, social and economic decisions should be taken at the lowest possible level

Foreign policy must uphold human rights, democracy, the rule of law, and respect international law, preserving and building peace through multilateral solutions

1.1 Climate and Environment

Our future is more important than the profits of individual companies. The policies of recent years are destroying the climate by protecting the interests of large corporations and allowing them to continue to exploit people and nature unchecked. Our earth is getting hotter and time is running out to save our natural resources and secure our future. With the destruction of our environment comes ever new resource conflicts – over water, habitats and healthy food. The current economic system of material growth and environmental exploitation is not only the root cause of climate change, but a cause of injustice. To stop climate change, it is essential to adopt an intersectional approach that recognizes those who are the most responsible for climate change are least likely to be affected by it when analysing the causes and effects of the climate crisis.

1.2 Feminism and LGBTQ+ Rights

In recent decades, feminists have won important achievements such as women's suffrage and legal independence from husbands or fathers. But it's not over yet! Women, intersex and trans people are still unable to make their own decisions about their bodies. Women are still often dependent on their partner's account balance. And supposedly "women's professions" are still paid far too poorly and are counted on the fact that someone will do them. We fight for intersectional feminism, a feminism that is anti-racist, anti-fascist, and draws from the LGBTQ+ and disability rights movements. Our feminism recognises diversity and the different ways in which privilege and oppression manifest in society. Join the feminist fight for real equality, an end to discrimination, and fair wages!

1.3 Social Justice

Our public infrastructure - our housing, healthcare, and education systems - have been devastated by austerity and systemic underinvestment. Everyone deserves a roof over their heads, free and accessible healthcare, and the opportunity to succeed. The Young Greens believe that the state must provide comprehensive and efficient health care, affordable housing, and secular education in all regions of the country. That is why fundamental social rights such as the right to housing, health and mobility must be enshrined in our constitution.

1.4 Green Economy

The constant compulsion to maximise profits leads to insecure jobs, poor salaries and climate destruction. We identify the root causes of the social and environmental crises as lying within the current economic system. We are committed to a democratic economic policy that is socially just, protects our environment, and increases our quality of life. The measurement of prosperity cannot be defined solely by gross national product and requires the inclusion of social and ecological factors. The green and feminist economy we want to build means the democratisation of the economy, the redistribution of wealth, a just transition and intragenerational equity. Instead of profits for the few, we support good working conditions and fair wages for all.

1.5 Democracy and Foreign Affairs

The protection of the rights of the people, representative democratic systems, lowering the voting age to 16 and protecting the right to organise and to take part in protests freely.

We believe in the European Project and that both national and European foreign policy must uphold human rights, democracy, the rule of law and the respect of international law; preserve and build peace; pursue multilateral solutions; and fight for effective action at the global level to fight climate change, the biodiversity crisis, and other global environmental and social challenges.

1.6 Our Objectives

The objective of the Young Greens is to promote the Principles above by:

- (a) active participation in the political process,
- (b) campaigning, canvassing and protesting, and
- (c) informing, educating, and involving the public.

The Young Greens operate on an all-island basis.

2. Young Greens Executive Committee

Introduction

The Young Greens are the youth wing of the Green Party / Comhaontas Glas, for any resident of Ireland aged 16-30 (or a student of any age) who supports social justice, climate action, sustainability, grassroots democracy, and peace.

2.1 The Committee

The Executive Committee is responsible for ensuring the medium and long-term development and expansion of the Young Greens.

The tasks of the Executive Committee include the following:

1. To advocate for Climate and Social Justice, particularly in areas relating to young people and minorities.
2. To support branches in third level institutions in organising students for climate action.
3. To organise Young Green participation in election campaigns.
4. To formulate proposals for Policy Council to consider.
5. The Executive Committee nominates a representative to sit on the Green Party Executive to provide and participate in Party decisions and operations.
6. To prepare an Annual Budget for, and to present the annual accounts to, the Party Treasurer and the Young Greens Annual Convention.
7. The meetings of the Executive Committee is minuted and the minutes is normally accessible on demand to Branches. The Executive Committee may however decide that certain matters are confidential and refuse access to minutes..

3. Young Greens Branches



3.1 College Branches

The Young Greens currently have branches in University College Dublin, Trinity College Dublin, University of Galway, Dublin City University, Technological University Dublin and Queens University Belfast. We also have branches in Northern Ireland and county Wicklow. Events include pub quizzes, pizza & policy, coffee hours, and panel discussions with Green TDs/MEPs/Senators.

3.2 Events and Campaigns

We run events of all sizes throughout the year, from Dáil trips and sea swims, to International Summer Camps, trips to Brussels, and the Samhain Masquerade Ball.

We put our principles into practice through activism based activities such as protests, marches, and voter registration. But activism also happens online through social media, online petitions, email campaigns, and zoom webinars. Some campaigns include capping the costs of student rents, trans rights and banning private jets.

Come election time, we mobilise Young Greens across the country to support Green Party Candidates in the Local, European and General Election campaigns.



4. Policy Development

4.1 Policy Council

The Green Party relies predominately on its members to create and direct policy. Policy Council develops, approves, and amends policies that are then adopted by the Party and used in election manifestos. Some policies that the Young Greens have been involved with forming include:

- Reproductive Rights
- Drug decriminalisation
- Housing
- Education
- LGBTQI+ Rights
- Banning conversion therapy
- Banning Private Jets

4.2 Policy groups

Policy Council regularly sets up Policy Groups to review existing policies and create new ones where we have a gap. When new groups are set up an email is sent to all party members inviting them to sign up. Groups elect a convenor and collaborate to draft a policy document.

There are 48 groups working on a variety of policies. Some of them are Animal Welfare, Climate Change, LGBTQI+, Irish Language, Equality, Rural Affairs, Housing and Homelessness, Flexible Working, Migration, Marine, Political Reform, Reproductive Rights, and many others.

5. Politics and Politicians


The Green Party currently has 12 TDs, 5 Senators, 2 MEPs and 46 councillors. [Green Party Northern Ireland](#) has five councillors.

The Republic of Ireland is divided into:

- 39 Dail Constituencies, from which TDs are elected and
- 166 Local Electoral Areas, from which councillors are elected.

The next Local and European Elections will be in June of 2024.

6. Federation of Young European Greens

6.1 FYEG

FYEG is the European umbrella organisation for Young Green organisations from all over the continent, from Georgia to Ireland and from Cyprus to Norway. Member organisations comprise various backgrounds: local ecological groups, student unions, youth wings of Green parties and Green Youth NGOs. In addition, they are also the independent, official youth wing of the European Green Party (EGP).

The Young Greens/Óige Ghlas have a rich history of engaging with European partners and fostering strong connections with (FYEG). For several years, Óige Ghlas has actively participated in European events, notably attending the FYEG Mental Health summer camp in France in 2022 and holding a significant presence at the 2023 FYEG General Assembly held in Barcelona, where we had the largest delegation among all member organisations. The primary point of contact between us and FYEG is our International Liaison Officer (ILO), who regularly participates in quarterly meetings representing Ireland in the northern region of FYEG.
